**Case History:** Master Shaik Abdul Khader is 7 years old boy suffering from a congenital heart disease and needs TOF repair + Tap (*Corrective repair of tetralogy of Fallot involves closure of the ventricular septal defect with a synthetic Dacron patch so that the blood can flow normally from the left ventricle to the aorta*). Due to their financial condition they had been going door to door for financial support and hence could not operate Master Shaik Abdul Khader. His health started deteriorating day by day and they took him to Rainbow Children's Heart Institute, Hyderabad, Telangana. Doctors informed them that he requires an urgent Open Heart Surgery as early as possible.

**Family Background:** His father works as an autorickshaw driver in Nizamabad, Telangana and his mother is a house wife. His father earns only Rs.4833/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Master Shaik Abdul Khader.
