Case History: Master Abdul Rafe Saber Ahemad Qureshi is 2 years old boy suffering from a congenital heart disease PDA (*Patent ductus arteriosus is a condition in which the ductus arteriosus does not close. The word "patent" means open. The ductus arteriosus is a blood vessel that allows blood to go around the baby's lungs before birth*) and he needs to undergo PDA device closure. Due to their poor financial condition they had been going door to door for financial support and hence could not operate Master Abdul Rafe Saber Ahemad Qureshi. His health started deteriorating day by day and his parents' took him to Balaji Heart Hospital & Diagnostic Centre, Byculla, Mumbai. Doctors informed them that he requires an urgent Open Heart Surgery as early as possible.

Family Background: His father works as a farmer in Parbhani District, Maharashtra and his mother is a house wife. His father earns only Rs. 4166/- per month. Since the entire family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Master Abdul Rafe Saber Ahemad Qureshi.
