**Case History:** Master Mohd. Atif Dildar suffering from non-metastatic osteosarcoma of right proximal tibia (*Cancer starts when cells in the body begin to grow out of control. Cells in nearly any part of the body can become cancer and can spread to other areas of the body. Osteosarcoma is the most common type of cancer that starts in the bones. The cancer cells in these tumors looks like early forms of bone cells that normally help make new bone tissue, but the bone tissue in the an osteosarcoma is not as strong as that of normal bones*). Due to their financial condition they had been going door to door for financial support and hence could not treat Master Mohd. Atif Dildar. His health started deteriorating day by day and they took him to Somaiya Ayurvihar-Asian Cancer Institute, Mumbai. Doctors informed them that he requires urgent surgery & chemotherapy as early as possible.

**Family Background:** His father had a shop but now he is not working and his mother is a domestic servant. They came from Uttar Pradesh to Mumbai for their livelihood. His mother earns only Rs.5000/- per month. Since she has to take care of the family alone and she naturally is not in a position to bear the cost of the treatment of Master Mohd. Atif Dildar.
