Case History: Baby Devyani Deepak Shinde suffering from Acute Lymphoblastic Leukemia (ALL) (*Type of Blood Cancer*) of the lymphoid line of blood cells characterized by the development of large numbers of immature lymphocytes. Symptoms may include enlarged lymph nodes, fever, feeling tired, pale skin colour, fever, easy bleeding or bruising, enlarged lymph nodes, or bone pain. Treatments may include chemotherapy or targeted drugs that specifically kill cancer cells). Due to their financial condition they had been going door to door for financial support and hence could not treat Baby Devyani Deepak Shinde. Her health started deteriorating day by day and they took her to Sahyadri Speciality Hospital. Doctors informed them that she requires urgent chemotherapy as early as possible.

Family Background: Her father works in a garage in Taluka-Haveli- Dist. Pune, Maharashtra and her mother is a house wife. Her father earns only Rs.5000/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Baby Devyani Deepak Shinde.
