If the hole is too big to close with the device or in the wrong position, the hole will be closed with surgery) ICR of ASD closure. Due to their poor financial condition they had been going door to door for financial support and hence could not operate Miss Ganga Sandip Vyavhare. Her health started deteriorating day by day, her parents' took her to Balaji Heart Hospital & Diagnostic Centre, Byculla, Mumbai. Doctors informed them that she requires an urgent Open Heart Surgery as early as possible.

Family Background: His father and mother work as a farmers in Solapur District, Maharashtra. His father earns only Rs. 4333/- per month. Since the entire family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Miss Ganga Sandip Vyavhare.
