Case History: Baby Garima Lalit Garade is 1year old baby girl suffering from Perimembranous VSD (*It may spontaneously decrease in size and eventually close*) and she needs to undergo ICR of VSD Closure (*is usually performed by sewing a patch of fabric or pericardium (the normal lining around the outside of the heart) over the VSD to close it completely. The normal heart lining tissue eventually grows to cover this patch and it becomes a permanent part of the heart*). Due to their poor financial condition they had been going door to door for financial support and hence could not operate Baby Garima Lalit Garade. Her health started deteriorating day by day, her parents took her to Balaji Heart Hospital & Diagnostic Center, Byculla, Mumbai. Doctors informed them that she requires an urgent Open Heart Surgery as early as possible.

Family Background: Her father works as a Labourer in Gadchiroli, Maharashtra and her mother is a housewife. Her father earns only Rs. 2083/- per month. Since the entire family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Baby Garima Lalit Garade.
