Case History: Master Gopal Joyardar suffering from B-Cell Acute Lymphocytic Leukemia (ALL) (*It is a type of cancer of the blood and bone marrow—the spongy tissue inside bones where blood cells are made. The disease progresses rapidly and creates immature blood cells, rather than mature ones. Treatments may include chemotherapy or targeted drugs that specifically kill cancer cells*). Due to their financial condition they had been going door to door for financial support and hence could not treat Master Gopal Joyardar. His health started deteriorating day by day and they took him to NH Narayana Superspeciality Hospital, Howrah, West Bengal. Doctors informed them that he requires urgent chemotherapy as early as possible.

Family Background: His father works as a farmer in Murshidabad, West Bengal and his mother is a house wife. His father earns only Rs.5000/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Master Gopal Joyardar.
