Case History: Baby of Jyoti Yadav, 1 month old is currently under treatment for problems of extreme prematurity, extreme low birth weight, respiratory distress syndrome, hyperkalemia, hypernatremia, clinical early onset sepsis, (*Early acquired hypernatremia in the ICU has been found to be a frequent complication in patients with severe sepsis*) bilateral grade III IVH and neonatal hyperbilirunemia (*or jaundice is a life threatening disorder in newborns. It is a multifactorial disorder with many symptoms. Generally, the physiological jaundice is the most prevalent type however in some regions pathological jaundice is also common*). He is currently on mechanical ventilator support, IV antibiotics and IV fluids. Due to the financial condition they had been going door to door for financial support. The baby is admitted in Surya Children's Medicare Pvt. Ltd. Mumbai. This brave infant needs your help and support to continue his treatment in the NICU.

Family Background: His father works in a small company as a mechanic in Mumbai and his mother is a house wife. His father earns only Rs.10,000/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of his baby.
