Case History: Master Pranai Chandraiah is 5 months old baby boy suffering from a congenital heart disease and needs VSD closure) (VSD is an opening in the wall (septum) dividing the two lower chambers of the heart (ventricles). Normally, this wall closes before birth. When it doesn't, oxygen-rich blood in the left chamber can mix oxygen-poor blood in the right one). Due to their financial condition they had been going door to door for financial support and hence could not operate Master Pranai Chandraiah. His health started deteriorating day by day and they took him to Rainbow Children's Heart Institute, Hyderabad, Telangana. Doctors informed them that he requires an urgent Open Heart Surgery as early as possible.

Family Background: His father works as a labourer in the farm on daily wages in Nalgonda District, Telangana and his mother is a house wife. His father earns only Rs.4166/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Master Pranai Chandraiah.
