**Case History:** Master Sai Arvind Reke is 6 months old baby boy suffering from a congenital heart disease (Tetralogy of Fallot- (Is a cardiac anomaly that refers to a combination of four related heart defects that commonly occur together. The four defects include a ventricular septal defect (VSD), pulmonary valve stenosis, a misplaced aorta and a thickened right ventricular wall (right ventricular hypertrophy) with small branch PA's. He requires (ICR TOF with monocusp) (Tetralogy of Fallot with monocusp pulmonary valve reconstruction prevents pulmonary regurgitation for a variable period). Due to their financial condition they had been going door to door for financial support and hence could not operate Master Sai Arvind Reke. His health started deteriorating day by day and they took him to Asian Heart Institute & Research Centre Pvt. Ltd., Mumbai. Doctors informed them that he requires an urgent Open Heart Surgery as early as possible.

**Family Background:** His father works as a farmer in Ratnagiri, Maharashtra and his mother is a house wife. His father earns only Rs. 2000/- per month. Since the entire family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Master Sai Arvind Reke.
