Case History: Baby Seher Mansur Mujawar is a 2 months old baby girl suffering from a congenital heart disease (Tetralogy of Fallow with Absent Pulmonary Valve) (*Absent pulmonary valve is a rare congenital anomaly characterized by features of tetralogy of Fallot with either rudimentary ridges or the complete absence of pulmonic valve tissue and usually with a hypoplastic pulmonary valve annulus*) and she needs *Rastelli surgery*. Due to their financial condition they had been going door to door for financial support and hence could not operate Baby Seher Mansur Mujawar. Her health started deteriorating day by day and they took her to WOCKHARDT Hospitals Ltd, Mumbai Central. Doctors informed them that she requires an urgent Open Heart Surgery as early as possible.

Family Background: Her father works as a helper in a private company in Pune, Maharashtra and her mother is a house wife. Her father earns only Rs.7000/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Baby Seher Mansur Mujawar.
