Case History: Baby Mohd. Shayan Firoz Khan was diagnosed with dilated sigmoid colon and required surgical intervention as corrective procedure and he has to undergo soave's procedure. (*Soave's procedure is a way to avoid the risks of injury to pelvic structures inherent in the swenson procedure. The soave procedure consists of removing the mucosa and submucosa of the rectum and placing the pull-through bowel within a cuff of aganglionic muscle. The sigmoid colon is the last section of the bowel — the part that attaches to the rectum. The sigmoid contains a lot of muscle tissue*). Due to their financial condition they had been going door to door for financial support and hence could not treat Baby Mohd. Shayan Firoz Khan. His health started deteriorating day by day and they took him to The Children's Hospital, Mumbai. Doctors informed them that he requires urgent soave's procedure as early as possible.

Family Background: His father works in a hospital in Mumbai as a ward boy and his mother is a house wife. He earns only Rs.11,000/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Baby Mohd. Shayan Firoz Khan.
