Case History: Baby Vidiya Gorakh Deore suffering from Kyphoscoliosis (*It is an abnormal curve of the spine on two planes: the coronal plane, or side to side, and the saggital plane, or back to front. It is a combined spinal abnormality of two other conditions: kyphosis and scoliosis. Children with congenital scoliosis sometimes have other health issues, such as kidney or bladder problems.*). Due to their financial condition they had been going door to door for financial support and hence could not treat Baby Vidiya Gorakh Deore. Her health started deteriorating day by day and they took her to Jaslok Hospital, Mumbai. Doctors informed them that she requires scoliosis surgery at the earliest.

Family Background: Her father works as a farmer in Malegaon, Nashik, Maharashtra and her mother is a house wife. Her father earns only Rs.1750/- per month. Since he has to take care of the family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Baby Vidiya Gorakh Deore.
