**Case History:** Master Yash Suresh Nawle is 7 years old boy suffering from a congenital heart disease VSD (*Ventricular Septal Defect is a hole in the wall (septum) separating the ventricles of the heart VSD is the most common type of heart malformation present at birth (congenital heart disease). VSD lets blood shunt from the left ventricle to the right ventricle. The symptoms are poor eating, fast breathing or breathlessness and easy tiring and he needs to undergo ICR of VSD Closure.* Due to their poor financial condition they had been going door to door for financial support and hence could not operate Master Yash Suresh Nawle. His health started deteriorating day by day and his parents' took him to Balaji Heart Hospital & Diagnostic Centre, Byculla, Mumbai. Doctors informed them that he requires an urgent Open Heart Surgery as early as possible.

**Family Background:** His father works as a farmer in Chandrapur District, Maharashtra and his mother is a house wife. His father earns only Rs. 2,500/- per month. Since the entire family and his parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Master Yash Suresh Nawle.
