

#### Our breakthrough and achievements:

- \* Supporting education of street urchins, underprivileged children and slum dwellers by employing teachers.
- ★ Started a Bal Wadi (Pre-School) at Gorai 3, Borivali (W), Mumbai for educating tribal children.
- ★ Started of a Bal Wadi (Pre-School) at Kalyan for educating Brick Kiln migrant tribal children
- ★ Two portable class rooms placed in Gorai III slum and another at Kalyan for Brick Kiln children supported by M/s Ciena India Pvt. Ltd.
- \* Establishing, proper school to provide elementary education to about 65 migrant tribal slum children and 45 Brick Kiln workers children for whom going to a school is a dream.
- \* Funded, Master Omkar Matunge (suffering from Aplastic Anemia Bone Marrow Cancer) at P. D. Hinduja Hospital
- \* Supported chemotherapy and surgery of 11 year old girl child. Baby Tisha Fulsunge, she had tumor in her ovary at P. D. Hinduja Hospital.
- \* Supported Master Prakash Pawan, 5 year old boy, Baby Anya Pavan Rai, 6 months old, Baby Rohini S Jirange, 6 year old, for their Open Heart Surgeries at Seven Hills Hospital. Medical Support given to total 5 children.
- \* Abhilasha Foundation is supporting children for their Education who had undergone critical medical surgeries and have been recovered from their illness.
- ★ Supporting Orphanages (supporting 57 orphan and semi orphan children) and Old Age Homes (supporting 25 senior citizens)
- \* Calamity Relief to Kashmir flood affected victims supported 100 families with blankets, food grains, milk, cooking oil, bread, biscuits etc.
- ★ Calamity Relief to Nepal earthquake victims supported 60 families by giving them Bajaj Lanterns.

Abhilasha Foundation is dedicated to create positive transformation & believes in

#### AN OVERVIEW OF OUR PROJECTS AND PROGRAMMES

As per UNICEF "Development begins with the child. Children's welfare measure will lead to every aspect of the development of a nation economic, social and political. The Right of Children to free and compulsory Education (RTE) Act enacted by the Government of India 2010. The legislation entitles that all children aged between 6 and 14 years to a quality education, based on principles of equality and non-discrimination and to ensure that every child has his or her right to quality elementary education. Implementation of the Right to Education Act and child friendly schools, Student assessment, including class room-based comprehensive and continuous evaluation which feed into teacher education systems in order to improve teaching-learning education. Use of information and communication technology to expand access to and improve the quality of learning."

**EDUCATION:** Abhilasha Foundation is empowering these children through education and enhancing them in basic English language. To ensure quality education in English for underprivileged children that helps them attain fluency in communication and self confidence. With the help of E-Teach method helps children

- Learn correct diction and proper pronunciations
- Colourful animation and attractive visuals hold their attention
- Grasp quickly and easily
- > Overcome fear of speaking in English
- > Practice their skills by talking with the peers in English

#### BALWADI AND DAY CARE CENTRE AT GORAI III, BORIVALI



Abhilasha Foundation started a Bal Wadi & Day Care Center for imparting formal and non-formal education to the **65 tribal** children at Gorai-3 Borivali (West) Mumbai. These children are from tribal community hailing from Maharashtra and other parts of the state. The whole community is staying without water and electricity for the last 10 years. The children go to BMC schools.

A b h i l a s h a F o u n d a t i o n support and guide these children for English language.

We also counsel the school drop outs children to take admission in distance education and continue their education and also financially helping their parents.

**SCHOLARSHIP PROGRAMME:** Scholarship is being provided to the children of this community who secure 80% and above in 10th and 12th standard. These children are being counseled for their carrier. Abhilasha Foundation supported 10 girls, by giving scholarship for continuing their education.

**EDUCATIONAL/ PICNIC TOURS:** Abhilasha Foundation believes in taking out the underprivileged children for Educational tours which is an essential part of our programmes and a means of education and entertainment.







#### BAL WADI AND DAY CARE CENTRE IN KALYAN, THANE DISTRICT:

Abhilasha Foundation started a Balwadi and Day Care Centre in Kalyan, Thane District at Sri Malangad



(also known as Haji Malang) in Kalyan. The parents are mostly semi literate and are unable to provide educational support to their wards. Many workers in the brick kilns are from socially backward classes or migrants. The workers live in deplorable conditions. In most of the brick kiln worker's households, both

the parents are addicted to alcohol or tobacco. Education for children is almost

non-existent. Many of the parents themselves are illiterate and least inclined to strive for their children's education. Unless counseled they remain indifferent towards the educational need of the children. There are around 45 brick kiln workers children for whom school is a dream.

#### **MEDICAL SUPPORT:**



Abhilasha Foundation works with the children from the most marginalized, economically deprived families to support them in their treatment of critical medical surgeries. The parents usually do not have a huge amount of money to spend on the treatment of their children for such critical surgeries. The organization sponsors treatment of these underprivileged

children and helps them to get back to their normal lives. Abhilasha Foundation works voluntarily with various



reputed hospitals in Mumbai like P D Hinduja Hospital, Jaslok, SevenHills Hospital, Kokilaben Ambani Hospital, Wadia etc. and many such more hospitals to fund such critically ill patients so that they should not be deprived of medical help.



# MEDICAL SUPPORT BPL (BELOW POVERTY LINE) CHILDREN

Abhilasha Foundation provided financial medical support for 5 children to undergo their critical medical surgeries during this financial year. All the 5 children medical surgeries were done successfully and children are hale and hearty.



Financial support to Master Omkar Matunge 10 years old boy (suffering from Aplastic Anemia Bone Marrow Cancer) at PD Hinduja Hospital.



Financial support to Baby Tisha Fulsunge, 11 years old girl for her chemotherapy and surgery as she had tumor in her ovary at PD Hinduja Hospital.



Financial support to Master Prakash Pawan, 5 year old boy, for his Open Heart Surgery in Seven Hills Hospital.



Financial support to Baby Anya Pavan Rai, 6 months old, for her Open Heart Surgery in Seven Hills Hospital.



Financial support to Baby Rohini S Jirange, 6 year old, for her Open Heart Surgery in Seven Hills Hospital.





**ORPHANAGE SUPPORT:** An orphanage is a residential institution devoted to the care of orphans, semi orphans – children whose biological parents are deceased or otherwise unable or unwilling to take care of them. so, to provide help to such orphanages in terms of moral, educational, medical and the materialistic help through volunteer work which can provide realistic help is the key agenda of Abhilasha Foundation. Continued support to 57 orphan children for their holistic development.

#### **OLD AGE HOME:**

An Old Age Home one of the major worrying fact in the society. It is usually the place, a home for those old people who have no one to look after them or those who have been thrown out of their homes by their children. Abhilasha Foundation supports 25 senior citizens for their nutrition, shelter, medical and ensuring their physical, mental, spiritual and emotional well-being of each senior citizens.





#### **WOMEN EMPOWERMENT:**

Any society is identified by the empowerment of the women. Faster the women empowerment and self – reliance of women's happens in the society, progress of the society will be expedited in the same way. Following the same thought process Abhilasha Foundation supported 80 deprived and neglected women from the society.

#### **SELFHELPGROUPS:**

Self-Help is a process of sharing a common experience, challenge or concern. It is participatory in nature, and involves getting help, giving help, learning to help them self, as well as sharing knowledge and experience. Self-help groups are seen as instruments for a variety of goals including empowering women, developing leadership qualities among marginalized women. Abhilasha Foundation formed 8 self help group for 80 women's each group consisting of 10 women.



#### LIVELIHOOD TRAINING:

Abhilasha Foundation provides livelihood training to the women who are deprived and neglected from the society. Abhilasha Foundation has started to empower the women by imparting them with various training programmes like mattress making, beautician course and leather bag making etc. for income generation for their sustainability and livelihood.



#### **CALAMITY RELIEF:**

## Jammu & Kashmir Calamity Relief:

A natural disaster is a major adverse event like floods, volcanic eruptions, earthquakes, tsunamis, and other geologic processes there is an urgent need to reach out to many more affected families during any calamity or any natural disaster. Abhilasha Foundation provides relief during any natural calamity. Women and children are the worst affected victims of natural disasters. Abhilasha Foundation work to ensure their right to survival and development after any calamity by providing them immediate support to the marginalized



people. Abhilasha Foundation supported 100 families during the calamity disaster in Jammu & Kashmir.



## Nepal Calamity Relief:

Abhilasha Foundation provided 60 Bajaj Lanterns to 60 families in Nuwakot District of Nepal which was affected during the earthquake.

# TRUE LIFE STORIES OF CHILDREN WHO HAD UNDERGONE CRITICAL MEDICAL SURGERIES

Name : Master Omkar Matunge

Age : 11 years old

Name of the father : Mr. Bharat Jayasing Matunge

Name of the mother : Mrs. Radha Matunge

Siblings : 4 (sisters)
Occupation : Labourer

Case History: Master Omkar B Matunge who was suffering from APlastic Anaemia (Blood Cancer). Doctors advised him to go for 'Allergenic Bone Marrow Transplantation' at P D Hinduja National Hospital & Medical Research Centre. Day by the day his immune system got weaker and weaker and he frequently fell sick, causing excessive weakness in his frail body.



**Family Background :** His father is a daily wager and earns only Rs. 3000/- per month. They are from Kolhapur and his mother is a domestic servant. He has four sisters. His father did not have money for Omkar's treatment as he is a daily wager and has to take care of the whole family. Hence, he was searching for a donor who can financially support Master Omkar B Matunge's treatment. Thanks to the timely intervention of Abhilasha Foundation and he was financially supported for his treatment in P D Hinduja National Hospital & Medical Research Center.

Name : Baby Tisha Rajesh Fulsunge

Name of the father : Late Shri Rajesh Parasram Fulsunge

Name of the mother : Mrs. Varsha Rajesh Fulsunge

Siblings : 2 (Sisters)

Occupation : Domestic Servant

**Case History:** Baby Tisha Rajesh Fulsunge was suffering from Yolk Sac Tumor in the Stomach (The yolk sac is a membranous sack that lies underneath a developing egg. The yolk sac is involved in transporting nutrients to the developing embryo

before it attaches to the placenta). As there was a huge line of patients in TATA Memorial Hospital they told her to wait for sometime but her condition was deteriorating day by day and she was withering in pain. Hence, her neighbours suggested her to take her to P D Hinduja National Hospital & Medical Research Centre. The doctors at PD Hinduja National Hospital & Medical Research Centre advised her to go for chemotherapy and surgery.

**Family Background:** Her father was an auto rickshaw driver at Ulhasnagar and he died due to alcoholism. Her mother is a domestic servant and she has two elder sisters who are studying in 9 and 10th std. Hence, her mother was not in a position to bear the cost of her daughter's treatment and they were searching for donors who can support Baby Tisha Rajesh Fulsunge for her treatment. Thanks to the timely intervention of Abhilasha Foundation and she was financially supported for her treatment in P D Hinduja National Hospital & Medical Research Center.



# TRUE LIFE STORIES OF CHILDREN WHO HAD UNDERGONE CRITICAL MEDICAL SURGERIES

Name : Master Prakash Chandeshwar Paswan

Age : 5 year old Boy

Siblings : 2 brothers and 1 sister Studying in : Aangan Wadi in Bihar

Case History: Master Prakash Chandeshwar Paswan who was suffering from Congenital Heart Defect and required an Early Total Correction of the heart. Due to the congenital heart defect his nails, tongue had started turning blue. Hence, he required an early total correction of the heart.



Family Background: His father is a Gardner and working in a society in Mira Road and has 4 children. The elder son is not going to school and the second son is studying in 5th standard and other two children are studying in Aanganwadi in Bihar. His father came to Mumbai for their livelihood and has been working as a gardener in a society and his mother stays in Bihar and she is a house wife. He earns only Rs. 4800/-. Since, his entire family and parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of his son. Thanks to the timely intervention of Abhilasha Foundation and he was financially supported for his treatment in SevenHills Hospital, Mumbai.

Name : Baby Anya Pavan Rai Age : 8 months old baby

Name of the father : Mr. Pavan Ramdular Rai Name of the mother : Mrs. Supriya Pavan Rai

Siblings : No one Occupation of the father : Delivery man

Case History: Baby Anya Pavan Rai is 8 months old baby girl and needed early elective correction of the heart and she was always falling sick. Her parents were worried and were treating her with the local doctor in Mumbai. Baby Anya Rai was conceived after 18 years of their marriage and she is an angel of her parents. Doctors



informed them that Baby Anya Rai is suffering from VSD (Ventricular Septal Defect (VSD) is a heart malformation present at birth. A VSD, therefore, is a type of Congenital Heart Disease (CHD). The heart with a VSD has a hole in the wall (the septum) between its two lower chambers (the ventricles). Due to their financial condition they could not operate this baby girl. Her health started deteriorating and they took her to SevenHills Hospital. Hence, doctors in SevenHills Hospital informed them that she required an early total correction of the heart soon.

Family Background: Her father works as delivery man in one of the pharmaceutical company. Her father came to Mumbai for their livelihood and has been working in Mumbai and her mother is a house wife. He earns only Rs. 6000/- per month. Since, his entire family and parents are dependent on him, he naturally is not in a position to bear the cost of the treatment of Baby Anya Pavan Rai. Thanks to the timely intervention of Abhilasha Foundation and she was financially supported for her treatment in SevenHills Hospital.

Occupation of the father: Farmer in Solapur



Case History: Baby Rohini S Jirage 6 years and 2 months old baby girl and needed to undergo Intracardiac Repair of VSD (Ventricular Septal Defect (VSD) closure with Infundibular Resection for an open heart surgery of Tetralogy of Fallot. Doctors at SevenHills Hospital informed them that Baby Rohini S Jirage is suffering from VSD. Due to their financial condition they could not operate this baby girl. Doctors at SevenHills Hospital informed them that she required urgently an open heart surgery.

Family Background: Her father and mother worked as farmers in Solapur. He earned only Rs. 1750/-per month. Since, his entire family and parents were dependent on him, he naturally was not in a position to bear the cost of the surgery and treatment of their daughter Baby Rohini S Jirage. Thanks to the timely intervention of Abhilasha Foundation and she was financially supported for her surgery and treatment in SevenHills Hospital.
